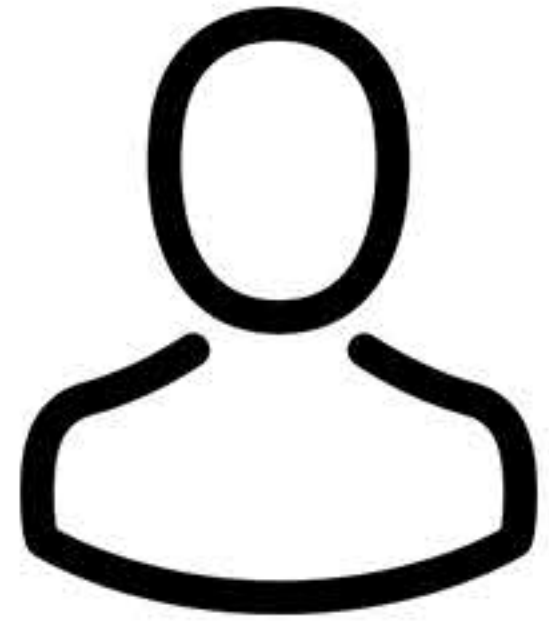

# FREQUENTLY ASKED QUESTIONS

## **What is SARS Debt?**

SARS Debt takes the form of VAT Debt, or Tax Debt. This includes PAYE debt and Income Tax debt. You are legally required to pay SARS, and if you fail to make payments, you are incurring SARS Debt which makes you liable for penalties and, potentially, criminal prosecution.

## **How do I resolve my SARS Debt?**

When you employ us to resolve your SARS Debt, we negotiate a suitable arrangement with SARS based on your affordability and financial situation. Tax Debt Relief boasts a 100% success rate and we are guaranteed to find a solution that suits you financially, whilst halting criminal prosecution and further penalties that could potentially be imposed by SARS.

## **What do I do if SARS has already actioned legal proceedings against me?**

If SARS has already instituted legal proceedings, it is imperative that you contact us urgently to resolve the matter and halt any and all legal action that has already been taken.
